Default has occurred in the payment of the Note and in the performance of the obligations of the Deed of Trust. Because of that default, Mesquite Springs Joint Venture, the owner and holder of the Note, has requested Substitute Trustee to sell the Property.

Formal notice is hereby given of Mesquite Springs Joint Venture's election to proceed against and sell both the real property and any personal property described in the Deed of Trust in accordance with Mesquite Springs Joint Venture's rights and remedies under the Deed of Trust and section 9.604(a) of the Texas Business and Commerce Code.


