
The next Commissioners' Court will be on Tuesday, May 12, 2026, at 10:00 a.m.

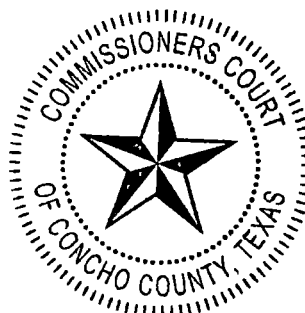


